



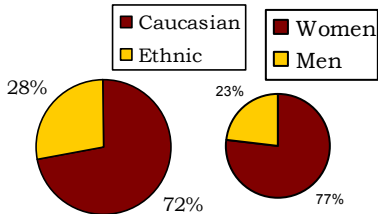

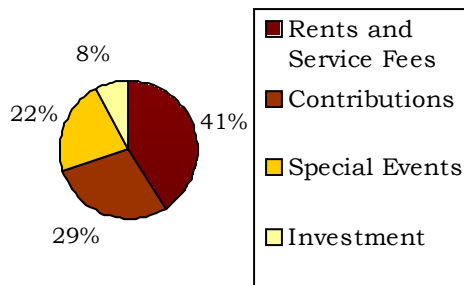

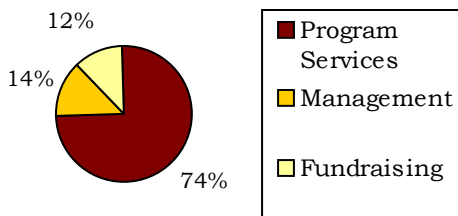

Your continued support makes it possible for us to provide a comfortable home, nutritious meals, supervision and social activities for up to 85 senior citizens each year.

Once again we have reason to celebrate at St. Luke's Home. Writing this letter each year offers us the opportunity to revisit the good times, be grateful for our many blessings, and say thank you for the many ways the community supports the residents of our Home.

Here are just a few highlights of 2007:

- ◆ Because of the generous support of the Old Pueblo, the Board of Trustees and staff of St. Luke's continued to provide independence, dignity and a high quality of life for our seniors without drawing from our reserves. We were once again able to maintain our waiting list and a full house throughout the year.
- ◆ The residents enjoyed many social events throughout the year, hosted by various outside agencies and local businesses. The residents enjoyed ice cream socials, pizza/bingo parties, birthday and holiday parties and various performances put on by the Tucson Prunes, students from the Arizona School for the Deaf and Blind, the St. Andrew's Sisters, Merri Makers, Tucson Regional Ballet, Sweetheart and her Pals, Ironwood OB/GYN, Pima Partnership High School, the Board of Visitors and United Way of Tucson.
- ◆ Over 160 volunteers from UPS, Davis Monthan Air Force Base, IBM, Caterpillar, the University of Arizona, Wells Fargo Bank and United Way pitched in to give St. Luke's a fall cleaning, inside and out, and host recreational activities during the United Way Days of Caring.
- ◆ The Board of Visitors remain the Shining Stars of St. Luke's with the 88th Annual Baile de las Flores held in February 2007. The event raised a record-breaking \$181,827 for the Home and a good time was had by all.
- ◆ Sensational Settings celebrated its twelfth year in a new venue at the Jewish Community Center, drawing a record crowd of 500 guests. Blue House Catering provided splendid fare for the event which hosted over 40 table designers, a fashion show, floral design demonstration and holiday dessert demonstration while raising over \$54,981 for the Home.
- ◆ With the sale of the Huntington house and generous donations from the Tucson Heritage Fund, the Elizabeth Ann Parkman Foundation, the Woodrow Master Revocable Trust and the Patricia and Charles M. Pettis Endowment Fund, we were able to pay down the mortgage by approximately \$158,000 in 2007.

All of this became a reality in 2007 because of the support of people like you. Donors, volunteers and local businesses of the Old Pueblo make it possible for St. Luke's Home to continue our Tradition of Serving.
