FAQS

What is St. Luke's Home?

St. Luke's Home is a 64-unit assisted living facility in Tucson for elderly women, men and couples of limited financial means. St Luke's in the Desert, Inc., a non-denominational non-profit organization, oversees the needs of the Home.

How will this money be used?

Your contribution will benefit the residents directly by providing much-needed funds for their basic needs. **\$50** will provide bed linens and towels for two residents for one year · **\$200** will provide meals for two residents for one week · **\$400** will provide routine first aid supplies for all residents for six months.

How much could I claim on my Arizona Tax Return?

Married, filing jointly: \$400
Married, filing separately: \$200
Single/unmarried head of household: \$200

And on my Federal Taxes?

For example, an eligible married couple in the 25% marginal tax bracket could receive the following benefit:

\$400 Arizona tax credit savings
+ \$100 Federal savings ($\$400 \times 25\% = \100)

= \$500 total tax savings

But, can I still contribute to schools?

YES, you can give to all three! The Arizona State Tax credits available for contributions to public school extra-curricular activities, private school tuition, and charities that provide assistance to the working poor like St. Luke's Home **can ALL be taken in the same year.** If you're like many Arizonans who contribute to schools in our state through tax credits, you don't have to choose between the three tax credits —**make use of all three!**

How can I contribute?

- Make a contribution to St Luke's in the Desert, Inc. by December 31.
- Apply up to \$400 of that contribution as a tax credit on your 2007 Arizona State Income Tax Return by filing Form 321, "Charities That Provide Assistance to the Working Poor."
- Apply the contribution as a tax deduction on your 2007 Federal Return.
- Everyone's tax situation is different, so **please remember to check with your tax advisor** to determine eligibility.
